

## **Terms and conditions for Holdsworth end of year appeal hamper raffle**

### **1. Overview**

Every donor to the Holdsworth Community end of year appeal will be entered into the Hamper draw, unless they advise they do not wish to be entered.

By participating in the Holdsworth end of year appeal hamper draw, you agree to the following terms and conditions. This prize draw is organised by Holdsworth Community, located at 64 Holdsworth Street Woollahra, in partnership with local businesses that have donated products and services and in conjunction with Holdsworth's end of year fundraising Tax Appeal. Should mention authority to fundraise.

The prize has been created in grateful recognition of all gifts to Holdsworth.

### **2. Eligibility**

- The Hamper draw is open to individuals aged 18 or older.
- Employees of Holdsworth are not eligible to participate.

### **3. How to enter**

- To enter, make a donation to Holdsworth via the designated QR code or at [www.holdsworth.org.au/donate](http://www.holdsworth.org.au/donate) or by calling us on 02 9302 3600.
- Each donor is automatically entered into the raffle once the donation is successfully processed.
- Only one entry per donor, regardless of the donation amount.

### **4. Entry period**

- Entry to the Hamper draw will be provided for all donations to Holdsworth during the period begins on 11<sup>th</sup> November and ends on 11<sup>th</sup> January 2025 (midnight).
- Donations received outside of this entry period will not be eligible for the Hamper draw.

### **5. Prize**

- The prize consists of a Holdsworth Hamper, which includes products and services generously donated by local businesses in recognition of Holdsworth's service to the community.
- The exact contents of the hamper will be specified through Holdsworth social media.

### **6. Winner selection and notification**

- The Hamper draw winner will be randomly selected on Friday 17 January 2025.
- Holdsworth will notify the winner via the contact information provided during the donation process as soon as possible following the draw. The winner must respond within 10 business days (ie by 31 January 2024) to claim their prize.

- If the winner does not respond within the specified time, Holdsworth reserves the right to select an alternate winner.
- The winner will be announced on Holdsworth social media and website once the prize has been collected (by 31 January 2024).

#### 7. Prize collection

- The winner must collect the hamper in person at our Holdsworth office at 64 Holdsworth Street, Woollahra or arrange for delivery at their own cost if applicable.
- Holdsworth is not responsible for any damage or loss of the hamper after it has been collected by the winner.

#### 8. Use of personal information

- By participating in the Hamper draw, entrants consent to the collection and use of their personal information for the purposes of administration of the draw.
- Holdsworth will handle all personal information in accordance with its Privacy Policy, available online at [www.holdsworth.org.au/privacy-policy/](http://www.holdsworth.org.au/privacy-policy/)
- Holdsworth, its partners, and local businesses that have contributed to the hamper will not be liable for any loss or damage resulting from participation in the prize draw or the acceptance and use of the prize.
- The prize is non-transferable, non-exchangeable, and cannot be redeemed for cash or other products/services.
